**Subject: Directives and instructions for admissions for the session 2023-24 at undergraduate level through online registration process.**

Dear Sir/Madam,

With reference to the subject as stated above concerning online admissions at undergraduates level in all the affiliating colleges, it is to inform you that in the interest of students and on the request of colleges, the university while simplifying the admission procedure has taken decision that for the session 2023-24, all the online admissions based on merit shall be done by the colleges themselves strictly in accordance to Pravesh Niyamavali and the ordinance governing the concerned programmes.

The detailed admission procedure shall be as per details given below:-

1. The whole admission process shall be conducted by the colleges in a transparent manner maintaining proper sanctity and strictly following the reservation policy of state government as well as the act/statutes, the ordinances governing the said programme and the Pavesh Niyamawali of 2023-24.
2. This admission process is for all the admissions at undergraduate level pertaining to session 2023-24 (excluding those programmes where admissions are to be done through Entrance Examinations).
3. The student after duly filling the registration form and depositing online the requisite registration fees of Rs. 150/- (on online portal), may apply

in the programmes of their choice in one or more than one college wherever they are willing to seek admission based on their eligibility. The duly filled registration form may be submitted to maximum of 10 colleges of his/her choice along with photocopies of mark sheets testimonials and 05 recent photographs.

4. In the academic session 2023-24, all the admissions to be done through online registration process shall be done by the colleges themselves. If at any stage in any of the college it is found that the college has violated or not complied with any of admission provision, the said admissions shall not be validated by university and shall be void and in such cases the admission registration shall also be liable to be cancelled.
5. For admission in various programmes all the colleges will publish advertisement/ press release/ notice inviting applications from students in online/ offline mode in prescribed form as approved by the concerned college.
6. When the last date of receiving applications by the colleges is over (as notified by university in due course), each college will scrutinize the application forms and will prepare and display the merit list of all the eligible candidates.
7. The candidates at a time shall be allowed to take admission in only one programme in only one of the college. All the students are free to opt any of the programme as per their eligibility and availability of seats in the respective college. while taking admission it will be mandatory for every candidate to submit the photocopy of their academic and their necessary certificates/testimonials and transfer certificate in original in the college.
8. Once the merit list is displayed, it will be essential for the college to confirm admission online on the University portal through the login ID and password (Provided to colleges by University for the said purpose) on or before the last date as decided by university.
9. All the colleges before confirming admission at UG level must ensure that the candidate has submitted all the required academic documents (photocopy) and transfer certificate (in original) in the college and is fully eligible for admission in the chosen programme.

10. All the provisions of NEP- 2020 as decided by state government and duly incorporated by university in its Pravesh Niyamawali and concerned ordinances shall be applicable.

The schedule for online registration shall be as per details given below:

1.	The start of the process of online registration on University portal after depositing registration fee of Rs. 150/-	17.06.2023
2.	The last date for the process of online registration on University portal after depositing registration fee of Rs. 150/-	06.07.2023

Note:

1. The above registration dates are effective only for the undergraduate programmes whose eligibility is Intermediate.
2. The dates for display of merit list and confirmation of admission by the college on university portal shall be notified separately in due course.
3. For post graduate programmes the notification shall be issued separately.
